Notice Concerning Change in Specified Related Corporation

Activia Properties Inc. (“API”) announces a change in a specified related corporation of TLC REIT Management Inc. (“TRM”), to which API entrusts its asset management. Details are as follows:

1. Reason for the change

The total amount paid to SPADE HOUSE Limited Liability Company by API for acquisition of trust beneficiary interests in real estate, etc. (real estate, real estate leasehold rights and surface rights being herein collectively referred to as real estate, etc.) (“Trust Beneficiary Interest In Real Estate, Etc.”) in the past three years from the last day of the fiscal period ended May 31, 2019 (the 15th fiscal period from December 1, 2018 through May 31, 2019) was equivalent to 20% or more of the total amount paid or received by API for acquisition or transfer of real estate, etc. and Trust Beneficiary Interests In Real Estates, Etc. during the said period. Thus, SPADE HOUSE Limited Liability Company has fallen into “specified related corporation” (corporation engaged in the transactions set forth in Article 29-3, Paragraph 3, Item 2 of the Order for Enforcement of the Financial Instruments and Exchange Act).

But the concerned criteria was not met for the past three years from the last day of the fiscal period ended November 30, 2021 (the 20th fiscal period from June 1, 2021 through November 30, 2021) and thus no longer falls into “specified related corporation”.
